Word from the Chair

In 2024, Canada experienced an unprecedented year in terms of insured damage, surpassing the previous record set in 2016. According to CatIQ, the total cost of damage exceeded \$8.5 billion, driven by major events such as the Jasper Forest Fire in Alberta, the torrential rains from Hurricane Debby in Ontario and Quebec, and the hailstorm in Calgary Alberta.

In times of crisis, the Incident Command System (ICS) continues to prove that it plays a pivotal role managing incident response. Its structured approach to incident management promotes seamless collaboration and

cooperation among multiple agencies. ICS was notably utilized during the response to the Jasper Forest Fire, where Fed/Prov. and Municipal formed a Unified Command structure in unison to manage the complex situation,

As we look to the future, it is clear that the need for highly skilled incident management teams is growing. To meet these challenges, we are actively encouraging the development of Type 3 Incident Management Teams across Canada. Our new strategic plan for 2025-2028 focuses on expanding organizational capacity to support this critical need.

The current landscape is promising, with several provinces—Ontario, Quebec, and Nova Scotia—strengthening their response capabilities, including the establishment of national guard units or corps. We fully support these initiatives and are committed to ensuring that these new responders are well-educated in ICS. By doing so, they will join thousands of
